Topics of Discussion

Sanction requests for rides must be received 60 days before the actual ride date. This past ride season, 2 rides were cancelled due to emergency circumstances (government shutdown and flooding).

This is AERC's policy for emergency rescheduling: Sanction requests for new rides, ride date changes, or changes in the ride length must be received for approval by the Regional Director at least 90 days before the

actual ride date, and received by the AERC Administrative Office at least 60 days before the ride—so that proper notification of the ride can be made to AERC members. Sanctioning directors may allow, with the approval of the other regional director and the Executive Committee, sanctioning or ride change requests that are received after the 90/60 day period for emergency purposes only. However, sanctioning directors may allow, with the approval of the other regional director and the Executive Committee, a request for the inclusion of an additional distance to an already sanctioned ride if the request is submitted at least 30 days before the ride date to the Sanctioning Director. A non-refundable fee is required with ride sanction or re-sanction applications.

This is SEDRA's Current rule: Sanctioning must be received at least 60 days in advance. If a sanctioning request is received later than 60 days in advance, the ride may be sanctioned for mileage only, no points.

Should SEDRA have a procedure in place so ride managers will know what to do? If so, what should the procedure be?

Proposed Rule Changes

Proposed Bylaw Change:

The title for one of our officer positions is currently "Ride Secretary". Many confuse this with the ride secretary for an individual ride and have referred to this office as sanctioning secretary. In keeping with how most members refer to this office and to avoid confusion, the Board of Directors is asking that the terminology for that office be officially changed in our Bylaws to "Sanctioning Secretary".

Introductory Division

The purpose of the IDR/D division within SEDRA's awards program is to introduce distance riding/driving to those who would like to sample the sport and for those experienced riders and /or horses no longer able to complete a longer course. IDR/D events will count ONLY towards Lifetime mileage for horse and riders and no other SEDRA awards. The general idea of IDDs and IDRs is that they are a shorter version of the MO (Mileage Only) program that is already in place.

Last year, the membership voted to incorporate an IDR/IDD division in a 1 year test program. We had good participation, with some new riders and some "old" riders. Some of the new riders have already done some 25 mile rides. The vets and judges did hold the IDR horses to the same standards required by the longer distances.

This year, we'll vote on making the IDR a permanent part of our program. Only one change has been made (see the highlight), to say under rules instead of guidelines.

The BOD also proposes a test year for each of the following enhancements to the IDR program (if the proposed rule passes).

- 1. Add Ride and Tie to the IDR program, to include distances from 8 to 20 miles. Ride and Tie events may be held with sanctioned R&T events, or with a sanctioned endurance rides, and must follow those procedures and completion criteria already set up for R&T.
- 2. A SEDRA sponsored introductory distance clinic may hold an IDR/D if it is run under SEDRA's rules and guidelines.

PROPOSED RULES FOR INTRODUCTORY DISTANCE RIDES (IDR) AND DRIVES (IDD)

1. The purpose of the IDR/D division within SEDRA's awards program is to introduce distance riding/driving to those who would like to sample the sport and for those experienced riders and /or

horses no longer able to complete a longer course. IDR/D events will count ONLY towards Lifetime mileage for horse and riders and no other SEDRA awards, to include the Longevity Award.

- IDRs and IDDs can be offered only in conjunction with a SEDRA sanctioned Competitive Trail Ride/Drive (CTR/D) or Endurance ride at the discretion of Ride Management. IDD/Rs will be conducted under the same rules as a Mileage Only division. Ride Management may also offer a fun ride division which would receive no mileage, but keep safety in mind.
- 3. Mileage for IDRs and IDDs will be between 10-20 miles.
- 4. All SEDRA safety, procedural, and completion requirements are to be enforced for the miles to count.
 - a. If held in conjunction with a CTR/D, the IDR/D
 - i. Must follow those procedures and completion criteria already set up for the Mileage Only Division.
 - ii. A separate Trail Judge can be used for the IDR/D, if Ride Management feels that it is warranted.
 - b. If held in conjunction with an Endurance ride, the IDR
 - i. Must follow those procedures and completion criteria already set up for Limited Distance.
- 5. Hoof and leg protection devices are acceptable, as stated in the Mileage Only Division.
- Event Distances and Times (In conjunction with a CTR/D: times indicated are elapsed time, including one 20-minute hold. Hold is optional, but if no hold is scheduled, no adjustment on time is permitted. Standard 45 minute window applies with no assessed penalties. DQ if come in 30 minutes early or 30 minutes over time, again follow Mileage Only Division rules). (Pace set at 6mph average.)
 - a. 10 miles = 1:25-2:10
 - b. 12.5 miles = 1:50-2:35
 - c. 15 miles = 2:15-3:00
 - d. 18 miles = 2:45 3:30
 - e. 20 miles = 3:05 3:50
- 7. Event Distances and Times (In conjunction with an Endurance ride: one hold may be scheduled, but is not required. If no hold is scheduled, no adjustment on time is permitted.)
 - a. 10 miles = 2:30 hours maximum
 - b. 12.5 miles = 3 hours maximum
 - c. 15 miles = 4 hours maximum
 - d. 18 miles = 5 hours maximum
 - e. 20 miles = 5:15 hours maximum
- 8. Participation in an IDR/D does NOT constitute the official beginning of a rider's or horse's Rookie Season. The Rookie Season will officially begin with their first 25 mile minimum CTR/D or Limited Distance/ Endurance ride.
- 9. IDR/D is not eligible for elevating.
- 10. Any mileage before the beginning date of this test period cannot be purchased and will not count.
- 11. All other SEDRA rules apply (i.e., Rider/driver must be a member, horse must be nominated prior to the ride, etc. for miles to count.)
- 12. Either the ride manager will provide a list of IDR/D completions, or the rider will provide a copy of the rider card or scoresheet to the awards secretary as proof of completion. The card must be signed by a judge as complete, and show the ride time to verify that criteria were met.
- 13. This program will be a test program for the 2013-2014 ride season. After the test period is over, SEDRA membership will vote on whether the program will become permanent, have another test year with modifications, or be discontinued.
