## ENDURANCE RIDE

October 5&6, 2018

The ride will be held at the Skymont Scout Reservation near Altamont, TN, which is approximately 20 miles north of Monteagle, TN. The ride is sanctioned by AERC, SERA, and SEDRA. The ride will be governed by the rules of AERC/SERA.

The ride is Friday, Oct 5 and Saturday, Oct 6, 2018 and will offer distances of 25 and 50 miles each day. All riders will be required to wear a helmet at all times while on a horse.

The camping area is located in a beautiful wooded area next to a small lake. Camping is primitive (no hookups) but water is available for horses and people. You may high line, picket, or pen your horses but please do not tie them directly to a tree!

The camp is located on the top of the Cumberland Plateau and the entire trail system stays on the top. The trail is primarily woods trail and some firebreak roads. Footing is excellent with some rocky areas. There are sections of the trail on the Skymont Perimeter Trail and will offer some spectacular views of the plateau and valley, and maybe some color change!

Your veterinary crew will be; Head Vet Otis Schmitt, Treatment Vet Ken Marcella, and Control Vet Larry Olsen. The trails manager and co-manager of the ride is

Wendy Rosenbek. Timers will be Nancy Gooch and Samm Bartee. Farrier will be Chris Glover. Photographer will be Linda Touns.

Pre-ride registration will begin at 1pm Thursday, October 4, 2018 and vet-in will begin at 3pm and stop at 6:00pm. Ride meeting will be held in the Skymont Dining Hall at approximately 7pm on Thursday. Awards ceremony will be after dinner on Friday and Saturday also in the dining hall. On Friday ride meeting will take place before the awards. Completion awards will be given to all competitors. First Place, Top Ten, 1<sup>st</sup> Junior, High Vet Score and Best Condition will be awarded for each ride.

Meals will be available Friday night, Saturday night and Sunday morning. The meals will be prepared for us by the High Adventure Scout Crew who has fed us so well the last few years! The Friday and Saturday meals are included in the entry fee for the riders but you may purchase tickets for your crew and family. Please let us know the number of extra tickets you will need so that we can be prepared to serve you. Gas, diesel, propane, groceries and ice are available in Altamont.

The entry fee is \$100. Entry fee for juniors is \$70. Non AERC members will pay a \$15 day fee in addition to the entry fee. A \$25 non-refundable deposit is required with pre-registration. On site entries and entries post marked after Sep. 29, 2018 will pay a \$25 late fee. The late fee is assessed per rider not per horse or days, but please get your entries in early to avoid paying the late fee.

General housekeeping: Dogs on a leash at all times. No alcoholic beverages (this is a Scout camp after all!!) Generators off from 10pm until 5 am. Please take your trash with you as we do not have trash service there. Please put your manure and old hay at the designated collecting sites.

## Skymont Endurance Ride Liability Release

I wish to enter and participate in the Skymont Endurance Ride hosted by Troy J Nelson, to be held in Altamont, TN. The dates I may participate will October 3, through October 7, 2018. I have read the rules, conditions and regulations of the event and hereby agree to comply with them. As a participant in this ride, I agree to abide by the rules of all sanctioning organizations, including AERC and SERA and the aforementioned ride. I understand that endurance riding involves being in remote areas for extended periods of time, far from communications, transportation and medical facilities, that these areas have natural and manmade hazards which ride management cannot anticipate, identify, modify or eliminate. I understand that horses can be excited, difficult to control and unpredictable and that accidents can happen to anyone at any time. I agree to take full responsibility for myself and the animal that I am riding or is in my care. I will hold Troy J. Nelson, Skymont Scout Reservation, Cherokee Area Council, Boy Scouts of America, AERC, SERA, SEDRA and GERA, the officers of said organizations and all individual members thereof, and all ride personnel blameless for any accident, injury or loss that might occur due to my participation in the Skymont Endurance Ride. I further agree to hold any and all of the aforementioned individuals and organizations free from liability for such injury or loss. This release extends to all claims of every kind and nature whatsoever, whether known or unknown, and I expressly waive any benefits that I may otherwise have under provisions of the laws of Tennessee relating to the release of unknown claims. I understand that this release constitutes a limitation of my legal rights.

## Skymont Endurance Ride

The ride will be held on the beautiful trails at Skymont Scout Camp in Altamont, TN. This is a good opportunity for you to see what an endurance ride is like!! The trail will be right at 10 miles long, and will start at 10 am on both days. Your horse will need to be vetted in before the ride. Ideally, Thursday afternoon for the Friday ride, and Friday afternoon for the Saturday ride. Registration can be done pre-ride or at the ride starting at 1 pm on Thursday, October 5. Your registration entitles you to the pre-ride riders meeting, a pre-ride vet exam, the ride, a post ride vet exam, a dinner and completion award at the evening meeting after the ride. Please try to pre-register as our meals are prepared on site by a BSA adventure crew and they need to plan for numbers of meals. If you are planning to camp know that all camping is primitive. This is a scout camp and not a horse camp so you will need to secure your horses at your camp as there is no stalls, paddocks or barns.

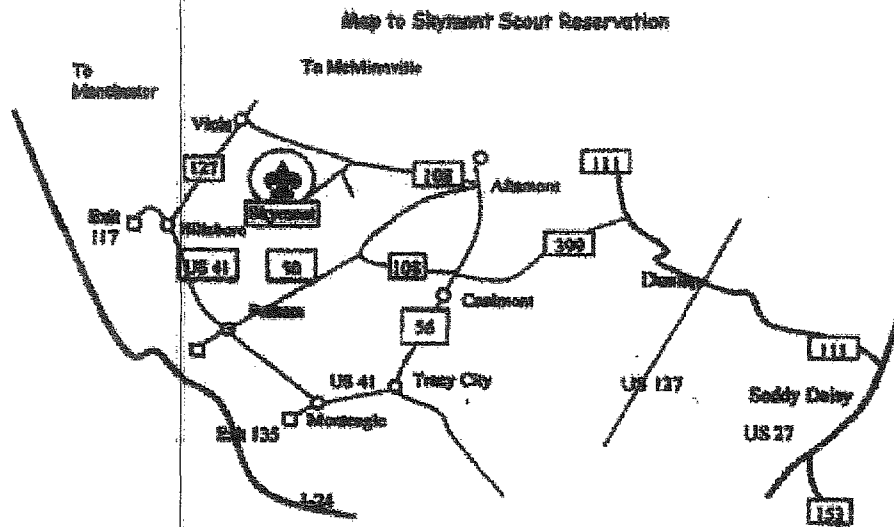

**From Chattanooga:** I-24 West to Exit 135 Monteagle. Turn right, go approximately 1 mile, turn right on US Hwy 41 travel 5.4 miles to Tracy City.

Turn left on Tennessee Hwy 56. Stay on 56 for 14.3 miles to Altamont NOTE: AT 8.7 MILES IN THE TOWN OF COALMONT THERE IS A MAJOR OPPORTUNITY TO TURN LEFT ONTO 108 NORTH. DO NOT TAKE THIS ONE! Continue on to Altamont.

At Altamont you will turn left onto 108 North. NOTE!! The first left turn onto 108 is SOUTH (do not turn in!), the next block over turn left on Hwy 108 NORTH There is a "Skymont" sign at the turn.

Take 108 North 4.7 miles and turn left on Cabbage Patch Road. There is a "Skymont" sign. The road immediately seems to split. Stay right. The camp is approx. 3 miles on right, large Skymont sign at the entrance.

**From Nashville:** I-24 East to Exit 117 (east of Manchester). Turn left and travel north on Arnold Center Rd. At US 41 turn right and travel south to Hillsboro. Turn left on Tennessee Hwy. 127. Travel North to Viola. In Viola, turn right on TN Hwy. 108 and travel east, going approximately 7 miles (drive up Cumberland Plateau). Turn right on Cabbage Patch Rd. at sign for Skymont. Bear right at fork. Skymont camp is approx. 3 miles on right.

**From Knoxville:** I-40 West to Crossville Exit 322 Peavine Rd. /TN 101. Turn left on TN 101, travel south to US 70. Turn right on US 70 and travel west. Turn left on US 127 and travel south to Dunlap. Turn right on TN 111 travel north to intersection of TN 399. Turn left on TN 399 travel west. At intersection of TN 399 and TN 108, turn right on TN 108 traveling through Gruetli-Laager to intersection in Coalmont of TN 56 and TN 108. Turn right on TN 56 and travel 6.6 miles to Altamont. At Altamont you will turn left onto 108 North. NOTE!! The first left turn onto 108 is SOUTH (do not turn in!), the next block over turn left on Hwy 108 NORTH There is a "Skymont" sign at the turn.
