**Registration** All FEI entries must be on line at [WWW.rideentry.org/Greenway](http://WWW.rideentry.org/Greenway) All FEI entries are automatically entered into AERC. AERC entry may be emailed to [dcshearer29@gmail.com](mailto:dcshearer29@gmail.com) or sent to Doug Shearer 2301 SE 85<sup>th</sup> St Ocala, FL 34480. Your FEI entry get into the AERC ride at no charge but please still send an entry. **You must pre-order meals or we cannot guarantee meals will available.**

**Deadline** FEI entries must be received at USEF and in the ride management online registration before 3pm on Dec 22, 2018 with Payment. After that entries accepted with payment of \$50 per ride entry in compliance with FEI regulations AERC entry must be in by Dec 26 to guarantee a meal and shirt. No late fees for AERC FEI riders please pay for ride entry on line but camping, Stalls, Meals, ground fees and AERC fee on AERC form.

**Directions** are online at [www.flhorsepark.com/](http://www.flhorsepark.com/) or Take exit 341 off I-75 to the east(right) 2.2miles then left (north) on 475 entrance is 2.6miles on Left

**Trails** are mixture of single and double track on the Cross Florida Greenway. Short distance of sand and root but mostly very good footing. Locals ride barefoot all the time. LED lights out on 100 and 75 Will be some away holds hay and water for horses Snacks and water for riders

**Camping** 42 electric spots with water available on first come basis. Permanent bathroom with showers are available. All dogs must be leashed at all times. Stalls are available. Camp will open on Dec 27 at 9am Early arrival can be arranged at horse park or local farms: contact Doug Shearer

**Cancellations** AERC cancellations will be refunded minus a \$25 fee. Meal tickets are nonrefundable FEI cancellation see website.

**Farrier and Vet Services** Riders are individually responsible for any farrier or vet treatment services needed.

**Food** Ride meeting meals the night before you ride are provided for rider. Food vendors will on site for lunches and breakfasts. Restaurants and fast food are available at I-75 interchange less than 1 mile away. You can but additional meals if not riding the next day and want to eat at dinner
