**Terrain:** Trails are mostly packed sand forest roads with a mixture of forestry gravel roads. May be sections of water. Hoof protection is suggested.

Awards: Completion, top 10, first place, best condition.

Camp: Primitive, plenty of well water for horses.

**Meals: All riders and crews are welcome-**Thursday night, pitch in dinner, ride management will provide fried chicken and green beans, please try to bring a dish to share. Friday night ride management will provide pizza and salad. If you want to bring a desert that would be great.

**Directions: From the North**: I-75 to exit # 382, Turn south (right) towards Williston, go 16.5 miles to stop sign and turn left, continue on 121/US 41. Go to Stoplight, turn right, continue on 121. Go to stoplight- turn left, continue on 121. Go to next stop light - turn right and continue on 121 another 16 miles. Turn left on CR 337, go 6 miles- Tidewater trailhead entrance will be on your left.

**From the South**: I-75 to exit # 341, Belleville/Dunnellon. Turn left on CR 484 toward Dunnellon. In Dunnellon, cross Hwy 41 at light and go to stop sign and turn right, continue on CR 40. Go another 4 miles and turn right on CR 336. Go 5.6 miles and turn right on 337, go <sup>1</sup>/<sub>4</sub> mile and turn right onto Saddle Pen Road, into the Tidewater trailhead entrance.
